THE MISSION

The mission of Love In The WORD Church's (LITWChurch) Forum for Global Evangelism (FFGE) is to carry the WORD of God to every corner of the earth by increasing the economic, community, and spiritual standards of living at the family level.

OUR METHOD

The method of FFGE is to create an economy in each area by creating small businesses that serve a community using the principle of the Logos of God. By building church buildings that are community centers of learning and care, the church becomes the focal point of each community for each family seeking a better way of sustaining life. The goal is to make each community self-sufficient by introducing the principles of fiscal management, marketing, personal hygiene, spiritual clarity and business administration. The church will be the center of global skill training such as language, technology, and the education of global systems, such as global economies, multinational humanitarian projects, public health coordination, to name a few topics.

WHAT WE ARE NOT INTERESTED IN

FFGE is not looking to amass enough resources to save the world, but it will invest its time and donated monies to "assist" economic, community, and spiritual development in the hope of establishing self-sustaining systems that eventually pay back a small share to perpetuate the mission until the Lord Jesus returns to give further instructions. We are a FAITH Christian Apostolic Ministry and NOT a bank or FUNDING ministry. ***If your only interest in LITWCHURCH is funding, please do NOT apply!*** We will only fund after our criteria is met. Among these criteria, but not limited to, is transparency, the presence biblical structure and administration (including the only God-approved church development of tithing & offerings), globally-accessible accounting record and bank account auditing, and of demonstrated honor, character, and integrity – to name a few. *FFGE will generally provide its services FREE OF CHARGE to help ministries qualify for funding by helping them organize their churches based on sound biblical, fiscal, and economic principles.*

WHO IS FFGE FOR ?

FFGE is a working forum of global ministry leaders that all possess the following characteristics:

- More concerned about spreading God's WORD than financially enriching themselves
- Seeking some financing to fund a project that is humanitarian, economic, community, and/or spiritual in scope
- Have a clear financial accounting system that tracks every asset and liability and that displays one's current fiscal condition with 100% transparency
- Adopts, executes, and lives by the written LITWChurch Honor Code which follows the standard of God
- Is supportive of God's family values and standard of living as written in the Holy Bible
- Willing to pay back a tenth to FFGE to perpetuate our Fund
- A commitment to efficiency and fiscal responsibility
- Willing to volunteer time to assist other FFGE members to realize their plan and objectives

WHY IS FFGE

FFGE was formed to manage the global requests for assistance in ministry that come into Love In The WORD Church. In order to be efficient and good stewards of donated funds and in order to prioritize requests, LITWChurch has developed a proprietary point system (to be described later in this document) to objectively suggest an order of priority. Rather than make unilateral decisions with a subjective motive, we found it best to include others who are already busy doing the work of God. FFGE will meet in cyberspace at least once per month, broadcasted on Facebook Live to the world. There will be a featured project of the month and we will encourage any discussion that helps the presenting FFGE member draw on the collective experiences of the other FFGE members. By critiquing and discussing the presented project, we hope to assist the presenting member to qualify for funding with FFGE.

LITWCHURCH MEMBERSHIP TYPES

LITWChurch and its network of churches has three types of memberships/associations:

1. Corporate Church (Type 1) :
 - a. These churches serve under the name of Love In The WORD Church and are supported financially from Corporate Headquarters.

- b. These churches are managed according to the Constitution (ByLaws) of LOVE IN THE WORD CHURCH INC, headquartered in Florida, USA.
 - c. Each church must be led by a LITWChurch-ordained pastor who reports to a Bishop ordained in country by the LITWChurch Board of Directors..
 - d. Pastors of these churches are ordained by corporate, trained by the Bishop in country, and serve at the sole pleasure of the Board of Directors as do ALL LITWChurch-ordained clergy.
 - e. Each LITWChurch-ordained pastor has one vote on the Mission Council in Country and reports to the LITWChurch-ordained Region or Mission Bishop for that country.
 - f. Each Bishop-in-country has one vote on the Corporate Regional/Mission Council that reports to Corporate Board of Directors as one vote.
 - g. These churches will control at least 60% of the donated funds for Missions work until there is no further need for that percentage.
 - h. The LITWChurch Board of Directors have the right to withdraw our charter and/or remove any Type 1 member unilaterally, and at its sole discretion, if the member breaches the ByLaws without curing such breach within 30 days of the notification of such breach.
 - i. Type 1 Members fall under the authority of the Presiding Bishop via the organizational structure as constituted at any given time by the Board of Directors
 - j. 20% of income goes to pastorate care. 10% of income goes to Country SEE for use of Type 1 churches IN COUNTRY ONLY!
 - k. There is **NO plan** to send ANY MONIES to Corporate. Corporate and Continental clergy and staff are funded by Corporate funding.
2. LITWChurch Network (Type 2) :
- a. These churches are churches that are autonomous. They are solely responsible for their own fiscal management.
 - b. These churches may receive funding, collectively, out of 30% of the donated funds for Missions work.
 - c. These churches are part of our network of churches and they add to their church names “a LITWChurch network entity”. This way, a ministry can stay independent but benefit from the global name recognition of Love In The WORD Church.
 - d. These churches can either elect to have “mentorship” or NOT have mentorship. Those WITH Mentorships are eligible to temporarily represent LITWChurch in country until a Corporate Bishop is ordained and they score higher for purposes of fund assistance than churches WITHOUT mentorship.
 - e. If the event that a Type 2 with Mentorship member is serving as an interim Bishop in Country, when the LITWChurch Board of Directors wishes to ordain a Mission Bishop in Country, the interim Type 2 Bishop shall have right of first refusal, but must convert their membership to Type 1 to exercise such right.
 - f. They elect to abide by the Bylaws of LOVE IN THE WORD CHURCH INC, but are managed by their own organizational documents. If there is an unreconcilable difference between

LITWChurch and the Type 2 member, the Type 2 member may terminate their membership pursuant to the funding documents that remain active.

- g. These churches present quarterly financial statements to corporate as part of their Transparency Pledge Requirement and must submit immediately to any request for information to assist in any auditing function contained within any allegation of wrongdoing or ByLaws breach.
 - h. Type 2 churches have no financial responsibility for Corporate or Type 1 churches, so they will have to pay a reasonable fee for any services that are rendered by FFGE or LITWChurch in general.
3. FFGE-Affiliate (Type 3) :
- a. These are by definition non-Christian organizations, ministries, or individuals.
 - b. These organizations and ministries are associated with LITWChurch and have no direct or indirect connection with our churches other than they want to qualify for FFGE benevolence funding
 - c. These entities command 10% of the donated funds for Missions work and essentially provide a place for LITWChurch to tithe to the Lord's Care for the world.
 - d. ***These ministries are not Christian and are permitted by approval, as long as they are involved in the work of loving and caring for humanity in the manner consistent with the standard of Jesus Christ as described in the Holy Bible and interpreted by LITWChurch Leadership.***
 - e. The fact upon which this decision rest is that Christians do NOT have a monopoly on goodness, goodwill, honor, integrity, and stewardship.
 - f. Any non-Christian member must submit to any request made by the LITWChurch Presiding Bishop and/or Board of Directors in its bid for FFGE Type 3 membership.
 - g. Type 3 FFGE non-Christian membership must be approved by the Presiding Bishop and ratified by the Corporate Board of Directors

REQUIREMENTS FOR FUNDING:

Any ministry receiving funding from FFGE must agree to, meet the qualifications of, and actively follow the following:

- Have an accounting system able to produce financial reports within 24-hours of request to be made to the public since we are using public donations.
- Produce source documents upon request of any claim made directly or indirectly in their financial reporting. This is for the purpose of auditing financial records.
- Be 100% transparent in how ALL currency is spent.
- Sign an Honor Code pledge and agree to be bound by it.
- Agree to pay 10% of gross receipts back to FFGE's Funding pool at some mutually agreed upon time.

- Be a member of FFGE of any type for at least six months.
- Participate as an active member of FFGE donating some of one's time to listen to and assist other FFGE members in attaining their goals. The more consistent participation, the more points for this metric.
- Be willing to answer any accusations of impropriety, mismanagement, or Honor violation.

SCORING SYSTEM FOR FUNDING

The exact scoring rubric for evaluating funding requests will change over time. This scoring scheme is called a "rubric". Each variable in the rubric is classified as one of two categories – FFGE-category and Project-category. Each category has a weight between category types (inter-Cat Percentage) that total 100% when added together. Within each category (Intra-Cat Percentage), each variable has a weight that totals 100% "within each category. Each variable has a maximum score of 100 points. Each variable condition will receive a point based on its value and the total or collective value will give priority to each project – a score from 0 to 100. The higher value being the highest priority. Currently the following variables are scored when prioritizing funding:

- Type of FFGE membership
- Months of FFGE membership
- Directly assists children
- Directly assists families
- Type of project (economic, community, or spiritual)
- Size of Funding
- Country of Funding
- Current LITWChurch Mission priorities
- Annual Attendance Percentage
- FFGE Involvement Percentage
- Project Pending Funding Wait Time (in months)
- Project Impact (number of people served in a month)

This will change over time and we shall modify as experience dictates.

The intellectual property for this system will be owned by Bishop D personally, and leased without cost to LITWChurch.

UTUME

Misheni ya Upendo Katika The WORD Church's (LITWChurch) Forum for Global Evangelism (FFGE) ni kupeleka NENO la Mungu kila kona ya dunia kwa kuongeza viwango vya maisha ya kiuchumi, kijamii na kiroho katika ngazi ya familia.

MBINU YETU

Mbinu ya FFGE ni kujenga uchumi katika kila eneo kwa kutengeneza biashara ndogo ndogo zinazohudumia jamii kwa kutumia kanuni ya Nembo ya Mungu. Kwa kujenga majengo ya kanisa ambayo ni vituo vya jamii vya kujifunza na kutunza, kanisa linakuwa kitovu cha kila jumuiya kwa kila familia kutafuta njia bora ya kudumisha maisha. Lengo ni kufanya kila jumuiya ijitegemee kwa kuanzisha kanuni za usimamizi wa fedha, uuzaji, usafi wa kibinafsi, uwazi wa kiroho na usimamizi wa biashara. Kanisa litakuwa kitovu cha mafunzo ya ustadi wa kimataifa kama vile lugha, teknolojia, na elimu ya mifumo ya kimataifa, kama vile uchumi wa kimataifa, miradi ya kimataifa ya kibinadamu, uratibu wa afya ya umma, kutaja mada chache.

JAMBO AMBALO HATUVUTIWI nalo

FFGE haitazami kukusanya rasilimali za kutosha kuokoa ulimwengu, lakini itawekeza wakati wake na kutoa pesa "kusaidia" maendeleo ya kiuchumi, kijamii na kiroho kwa matumaini ya kuanzisha mifumo ya kujitegemea ambayo hatimaye italipa sehemu ndogo kwa endeleza utume hadi Bwana Yesu atakaporudi kutoa maagizo zaidi. Sisi ni IMANI Christian Apostolic Ministry na SI huduma ya benki au FEDHA. Ikiwa nia yako pekee katika LITWCHURCH ni ufadhili, tafadhali USITUMIE Ombi! Tutafadhili tu baada ya vigezo vyetu kufikiwa. Miongoni mwa vigezo hivi, lakini sio tu, ni uwazi, uwepo wa muundo na usimamizi wa kibiblia (pamoja na maendeleo pekee ya kanisa yaliyoidhinishwa na Mungu ya zaka na matoleo), rekodi ya uhasibu inayofikiwa kimataifa na ukaguzi wa akaunti ya benki, na heshima iliyoonyeshwa, tabia. na uadilifu - kutaja machache. FFGE kwa ujumla itatoa huduma zake BILA MALIPO ili kusaidia huduma kuhitimu kupata ufadhili kwa kuwasaidia kupanga makanisa yao kulingana na kanuni nzuri za kibiblia, kifedha na kiuchumi.

FFGE NI KWA NANI?

FFGE ni jukwaa la kufanya kazi la viongozi wa wizara ya kimataifa ambao wote wana sifa zifuatazo:

- Kuhangaikia zaidi kueneza NENO la Mungu kuliko kujitajirisha wenyewe kifedha
- Kutafuta ufadhili wa kufadhili mradi ambao ni wa kibinadamu, kiuchumi, kijamii na/au wa kiroho katika wigo.
- Kuwa na mfumo wazi wa uhasibu wa fedha unaofuatilia kila mali na dhima na unaoonyesha hali ya sasa ya fedha kwa uwazi wa 100%.
- Hukubali, kutekeleza, na kuishi kwa Kanuni ya Heshima ya LITW Kanisa iliyoandikwa ambayo inafuata kiwango cha Mungu.
- Inaunga mkono maadili ya familia ya Mungu na kiwango cha maisha kama ilivyoandikwa katika Biblia Takatifu
- Tayari kulipa sehemu ya kumi kwa FFGE ili kuendeleza Mfuko wetu
- Kujitolea kwa ufanisi na uwajibikaji wa kifedha
- Kuwa tayari kujitolea kusaidia wanachama wengine wa FFGE kutambua mpango na malengo yao

KWANINI FFGE

FFGE iliundwa ili kusimamia maombi ya kimataifa ya usaidizi katika huduma ambayo yanakuja katika Kanisa la Upendo In The WORD. Ili kuwa wasimamizi wazuri na wazuri wa fedha zinazochangwa na ili kuyapa kipaumbele maombi, LITWChurch imeunda mfumo wa alama za umiliki (itakayoelezewa baadaye katika hati hii) ili kupendeleza kwa uwazi mpangilio wa kipaumbele. Badala ya kufanya maamuzi ya upande mmoja kwa nia ya kibinafsi, tuliona ni bora kuwajumuisha wengine ambao tayari wana shughuli nyingi katika kufanya kazi ya Mungu. FFGE itakutana kwenye mtandao angalau mara moja kwa mwezi, ikitangazwa ulimwenguni kote kwenye Facebook Live. Kutakuwa na mradi ulioangaziwa wa mwezi huu na tutahimiza mjadala wowote ambao unamsaidia mwanachama wa FFGE kutumia uzoefu wa pamoja wa wanachama wengine wa FFGE. Kwa kukosoa na kujadili mradi uliowasilishwa, tunatumai kusaidia mwanachama anayewasilisha kuhitimu kupata ufadhili na FFGE.

AINA ZA UANACHAMA LITWCCHCH

LITWChurch na mtandao wake wa makanisa ina aina tatu za washiriki/mashirika:

1. Kanisa la Ushirika (Aina ya 1):
 - a. Makanisa haya yanahudumu chini ya jina la Love In The WORD Church na yanasaidiwa kifedha kutoka Makao Makuu ya Shirika.
 - b. Makanisa haya yanasimamiwa kwa mujibu wa Katiba (ByLaws) ya LOVE IN THE WORD CHURCH INC, yenye makao yake makuu Florida, Marekani.
 - c. Kila kanisa lazima liongozwe na mchungaji aliyewekwa rasmi na LITW ambaye anaripoti kwa Askofu aliyewekwa wakfu nchini na Halmashauri ya Wakurugenzi ya LITW Kanisa.
 - d. Wachungaji wa makanisa haya huwekwa wakfu na ushirika, hufunzwa na Askofu nchini, na hutumikia kwa radhi pekee ya Halmashauri ya Wakurugenzi kama wafanyavyo makasisi WOTE waliowekwa rasmi na Kanisa LITW.
 - e. Kila mchungaji aliyewekwa rasmi na Kanisa LITW ana kura moja juu ya Baraza la Misheni Nchini na anaripoti kwa Mkoa uliowekwa wakfu na Kanisa LITW au Askofu wa Misheni wa nchi hiyo.

- f. Kila Askofu wa nchi ana kura moja juu ya Baraza la Ushirika la Mkoa/Misheni ambayo inaripoti kwa Bodi ya Wakurugenzi ya Biashara kama moja piga kura.
- g. Mekanisa haya yatadhibiti angalau 60% ya fedha zilizochangwa kwa ajili ya kazi ya Misheni hadi kusiwe na haja zaidi ya asilimia hiyo.
- h. Bodi ya Wakurugenzi ya LITW Church ina haki ya kuondoa hati yetu na/au kumwondoa mwanachama yeyote wa Aina ya 1 kwa upande mmoja, na kwa uamuzi wake pekee, ikiwa mwanachama atakiuka Sheria Ndogo bila kuponya ukiukaji huo ndani ya siku 30 baada ya taarifa ya ukiukaji huo.
- i. Wanachama wa Aina ya 1 wako chini ya mamlaka ya Askofu Mkuu kupitia muundo wa shirika kama ulivyowekwa wakati wowote na Halmashauri ya Wakurugenzi.
- j. 20% ya mapato huenda kwa uchungaji. 10% ya mapato huenda kwa Nchi TAZAMA kwa matumizi ya makanisa ya Aina ya 1 NCHINI PEKEE!
- k. HAKUNA mpango wa kutuma PESA YOYOTE kwa Shirika. Makasisi wa Mashirika na Bara na wafanyakazi wanafadhiliwa na ufadhili wa Mashirika.

2. Mtandao wa LITW Church:

- a. Mekanisa haya ni makanisa ambayo yanajitawala. Wanawajibika tu kwa usimamizi wao wa fedha.
- b. Mekanisa haya yanaweza kupokea ufadhili, kwa pamoja, kati ya 30% ya fedha zilizochangwa kwa ajili ya kazi ya Misheni.
- c. Mekanisa haya ni sehemu ya mtandao wetu wa makanisa na yanaongeza kwa majina ya makanisa yao "mtandao wa LITWChurch entity". Kwa njia hii, huduma inaweza kukaa huru lakini kufaidika na utambuzi wa jina la kimataifa la Upendo Katika Kanisa la WORD.
- d. Mekanisa haya yanaweza kuchagua kuwa na "ushauri" au KUTOKUWA na ushauri. WALE WENYE Ushauri wanastahiki kuwakilisha kwa muda Kanisa la LITW nchini hadi Askofu Mkuu atakapowekwa rasmi na watapata alama za juu zaidi kwa madhumuni ya usaidizi wa kifedha kuliko makanisa BILA ushauri.
- e. Iwapo tukio ambalo Mwanachama wa Aina ya 2 mwenye Ushauri anahudumu kama Askofu wa muda katika Nchi, wakati Halmashauri ya Wakurugenzi ya LITW Church inataka kumtawaza Askofu Misheni Nchini, Askofu wa Awamu ya 2 atakuwa na haki ya kwanza ya kukataa, lakini lazima uanachama wa Aina ya 1 ili kutekeleza haki hiyo.
- f. Wanachagua kutii Sheria Ndogo za LOVE IN THE WORD CHURCH INC, lakini wanasimamiwa na hati zao za shirika. Ikiwa kuna tofauti isiyoweza kusuluhishwa kati ya LITWChurch na Mwanachama wa Aina ya 2, mwanachama wa Aina ya 2 anaweza kukomesha uanachama wake kwa mujibu wa hati za ufadhili ambazo zitasalia amilifu.
- g. Mekanisa haya yanawasilisha taarifa za fedha za kila robo mwaka kwa shirika kama sehemu ya Masharti ya Ahadi ya Uwazi na lazima yawasilishe mara moja kwa ombi lolote la taarifa ili kusaidia katika shughuli yoyote ya ukaguzi iliyomo ndani ya madai yoyote ya kufanya makosa au uvunjaji wa Sheria Ndogo.
- h. Mekanisa ya Aina ya 2 hayana jukumu la kifedha kwa Makanisa ya Ushirika au Aina ya 1, kwa hivyo yatalazimika kulipa ada inayofaa kwa huduma zozote zinazotolewa na FFGE au LITW Church kwa ujumla.

3. FFGE-Affiliate:

- a. Haya ni kwa ufafanuzi mashirika, huduma, au watu binafsi zisizo za Kikristo.
- b. Mashirika na huduma hizi zinahusishwa na LITWChurch na hazina uhusiano wa moja kwa moja au usio wa moja kwa moja na makanisa yetu isipokuwa wanataka kuhitimu ufadhili wa hisani wa FFGE.
- c. Mashirika haya yanaamuru 10% ya fedha zilizochangwa kwa ajili ya kazi ya Misheni na kimsingi hutoa nafasi kwa Kanisa la LITW kutoa zaka kwa Huduma ya Bwana kwa ulimwengu.
- d. Huduma hizi si za Kikristo na zinaruhusiwa kwa kibali, mradi zinahusika katika kazi ya kupenda na kutunza ubinadamu kwa namna inayopata na kiwango cha Yesu Kristo kama ilivyoelezwa katika Biblia Takatifu na kufasiriwa na Uongozi wa LITW Church.
- e. Ukweli ambao uamuzi huu unategemea ni kwamba Wakristo HAWANA ukiritimba wa wema, nia njema, heshima, uadilifu, na uwakili.
- f. Mwanachama yeyote asiye Mkristo lazima awasilishe ombi lolote lililotolewa na Askofu Mkuu wa LITWKanisa na/au Halmashauri ya Wakurugenzi katika zabuni yake ya uanachama wa FFGE Aina ya 3.
- g. Uanachama wa aina 3 wa FFGE usio wa Kikristo lazima uidhinishwe na Askofu Mkuu na kuthibitishwa na Bodi ya Wakurugenzi wa Shirika.

MAHITAJI YA FEDHA:

Wizara yoyote inayopokea ufadhili kutoka kwa FFGE lazima ukubali, kukidhi sifa za, na kufuata kikamilifu yafuatayo:

LA MISSION

La mission de Love In The WORD Church (LITWChurch) Forum for Global Evangelism (FFGE) est de porter la PAROLE de Dieu dans tous les coins de la terre en augmentant le niveau de vie économique, communautaire et spirituel au niveau familial.

NOTRE MÉTHODE

La méthode de la FFGE est de créer une économie dans chaque domaine en créant de petites entreprises qui servent une communauté en utilisant le principe du Logos de Dieu. En construisant des bâtiments d'église qui sont des centres communautaires d'apprentissage et de soins, l'église devient le point central de chaque communauté pour chaque famille à la recherche d'un meilleur moyen de soutenir la vie. L'objectif est de rendre chaque communauté autonome en introduisant les principes de gestion fiscale, de marketing, d'hygiène personnelle, de clarté spirituelle et d'administration des affaires. L'église sera le centre de formation aux compétences mondiales telles que la langue, la technologie et l'éducation des systèmes mondiaux, tels que les économies mondiales, les projets humanitaires multinationaux, la coordination de la santé publique, pour n'en nommer que quelques-uns.

CE QUI NE NOUS INTÉRESSE PAS

La FFGE ne cherche pas à amasser suffisamment de ressources pour sauver le monde, mais elle investira son temps et ses dons pour « aider » le développement économique, communautaire et spirituel dans l'espoir d'établir des systèmes autonomes qui remboursent finalement une petite part à perpétuer la mission jusqu'à ce que le Seigneur Jésus revienne pour donner d'autres instructions. Nous sommes un ministère apostolique chrétien de FOI et NON une banque ou un ministère de FINANCEMENT. Si votre seul intérêt pour LITWCHURCH est le financement, veuillez NE PAS postuler ! Nous ne financerons qu'une fois nos critères remplis. Parmi ces critères, mais sans s'y limiter, se trouvent la transparence, la présence d'une structure et d'une administration bibliques (y compris le seul développement de la dîme et des offrandes approuvé par Dieu), un registre comptable et un audit de compte bancaire accessibles à l'échelle mondiale, et un honneur, caractère, et l'intégrité - pour n'en nommer que quelques-uns. La FFGE fournira généralement ses services GRATUITEMENT pour aider les ministères à se qualifier pour un financement en les aidant à organiser leurs églises sur la base de principes bibliques, fiscaux et économiques solides.

A QUI S'ADRESSE LA FFGE ?

La FFGE est un forum de travail de dirigeants de ministères mondiaux qui possèdent tous les caractéristiques suivantes :

- Plus soucieux de répandre la PAROLE de Dieu que de s'enrichir financièrement
- Recherche de financement pour financer un projet à portée humanitaire, économique, communautaire et/ou spirituelle
- Disposer d'un système de comptabilité financière clair qui suit chaque actif et passif et qui affiche sa situation fiscale actuelle avec une transparence à 100 %
- Adopte, exécute et vit selon le code d'honneur écrit LITWChurch qui suit la norme de Dieu
- Soutient les valeurs familiales et le niveau de vie de Dieu tels qu'ils sont écrits dans la Sainte Bible
- Désireux de rembourser un dixième à la FFGE pour pérenniser notre Fonds
- Un engagement envers l'efficacité et la responsabilité fiscale
- Disposé à offrir du temps pour aider d'autres membres de la FFGE à réaliser leur plan et leurs objectifs

POURQUOI LA FFGE

La FFGE a été formée pour gérer les demandes mondiales d'assistance dans le ministère qui entrent dans l'église Love In The WORD. Afin d'être efficace et de bien gérer les fonds donnés et afin de hiérarchiser les demandes, LITWChurch a développé un système de points exclusif (qui sera décrit plus loin dans ce document) pour suggérer objectivement un ordre de priorité. Plutôt que de prendre des décisions unilatérales avec un motif subjectif, nous avons trouvé préférable d'inclure d'autres qui sont déjà occupés à faire l'œuvre de Dieu. La FFGE se réunira dans le cyberspace au moins une fois par mois, diffusée sur Facebook Live au monde. Il y aura un projet vedette du mois et nous encouragerons toute discussion qui aide le membre présentateur de la FFGE à tirer parti des expériences collectives des autres membres de la FFGE. En critiquant et en discutant du projet présenté, nous espérons aider le membre présentateur à se qualifier pour un financement avec la FFGE.

TYPES D'ADHÉSION À L'ÉGLISE LITTLE

LITWChurch et son réseau d'églises ont trois types d'adhésions/associations :

1. Église corporative (Type 1) :

une. Ces églises servent sous le nom de Love In The WORD Church et sont soutenues financièrement par le siège social de l'entreprise.

b. Ces églises sont gérées conformément à la constitution (règlements) de LOVE IN THE WORD CHURCH INC, dont le siège est en Floride, aux États-Unis.

c. Chaque église doit être dirigée par un pasteur ordonné par la LITWChurch qui rend compte à un évêque ordonné dans le pays par le conseil d'administration de la LITWChurch.

ré. Les pasteurs de ces églises sont ordonnés par des corporations, formés par l'évêque du pays, et servent au seul plaisir du conseil d'administration comme le font TOUS les membres du clergé ordonné par l'Église.

e. Chaque pasteur ordonné par l'Église LITWC dispose d'une voix au Conseil de mission du pays et rend compte à la Région ordonnée par l'Église LITWC ou à l'Évêque de mission de ce pays.

F. Chaque évêque dans le pays dispose d'une voix au Conseil régional/de mission de l'entreprise qui rend compte au Conseil d'administration de l'entreprise en tant qu'un voter.

g. Ces églises contrôleront au moins 60% des fonds donnés pour le travail des missions jusqu'à ce qu'il n'y ait plus besoin de ce pourcentage.

h. Le conseil d'administration de LITWChurch a le droit de retirer notre charte et/ou de retirer tout membre de type 1 unilatéralement, et à sa seule discrétion, si le membre enfreint les statuts sans remédier à cette violation dans les 30 jours suivant la notification d'une telle violation.

je. Les membres de type 1 relèvent de l'autorité de l'évêque président via la structure organisationnelle telle qu'elle est constituée à tout moment par le conseil d'administration

j. 20% des revenus vont aux soins pastoraux. 10% des revenus vont au pays VOIR pour l'utilisation des églises de type 1 DANS LE PAYS UNIQUEMENT !

k. Il n'y a AUCUN projet d'envoyer AUCUNE ARGENT à Corporate. Le clergé et le personnel corporatifs et continentaux sont financés par le financement de l'entreprise.

2. Réseau de l'Église LITW :

une. Ces églises sont des églises autonomes. Ils sont seuls responsables de leur propre gestion fiscale.

b. Ces églises peuvent recevoir un financement, collectivement, sur 30% des fonds donnés pour le travail des missions.

c. Ces églises font partie de notre réseau d'églises et elles ajoutent à leurs noms d'église « une entité du réseau LITWChurch ». De cette façon, un ministère peut rester indépendant mais bénéficier de la reconnaissance mondiale du nom de Love In The WORD Church.

ré. Ces églises peuvent choisir d'avoir un « mentorat » ou de ne PAS avoir de mentorat. Ceux AVEC des mentorats sont éligibles pour représenter temporairement LITWChurch dans le pays jusqu'à ce qu'un évêque d'entreprise soit ordonné et ils obtiennent un score plus élevé aux fins d'aide financière que les églises SANS mentorat.

e. F. Ils choisissent de se conformer aux règlements de LOVE IN THE WORD CHURCH INC, mais sont gérés par leurs propres documents organisationnels. S'il existe une différence irréconciliable entre LITWChurch et le membre de type 2, le membre de type 2 peut résilier son adhésion conformément aux documents de financement qui restent actifs.

g. Ces églises présentent des états financiers trimestriels à l'entreprise dans le cadre de leur obligation de transparence et doivent se soumettre immédiatement à toute demande d'informations pour aider à toute fonction d'audit contenue dans toute allégation d'acte répréhensible ou de violation des statuts.

h. Les églises de type 2 n'ont aucune responsabilité financière pour les églises d'entreprise ou de type 1, elles devront donc payer des frais raisonnables pour tous les services rendus par FFGE ou LITWChurch en général.

3. Affilié FFGE :

une. Ce sont par définition des organisations, des ministères ou des individus non chrétiens.

b. Ces organisations et ministères sont associés à LITWChurch et n'ont aucun lien direct ou indirect avec nos églises autre qu'ils veulent se qualifier pour le financement de la bienfaisance FFGE

c. Ces entités commandent 10% des fonds donnés pour le travail des missions et fournissent essentiellement un lieu à LITWChurch pour donner la dîme à la sollicitude du Seigneur pour le monde.

ré. Ces ministères ne sont pas chrétiens et sont autorisés par approbation, tant qu'ils sont impliqués dans le travail d'aimer et de prendre soin de l'humanité d'une manière compatible avec le standard de Jésus-Christ tel que décrit dans la Sainte Bible et interprété par LITWChurch Leadership.

e. Le fait sur lequel repose cette décision est que les chrétiens n'ont PAS le monopole de la bonté, de la bonne volonté, de l'honneur, de l'intégrité et de l'intendance.

CONDITIONS DE FINANCEMENT :

Tout ministère recevant un financement de la FFGE doit accepter, répondre aux qualifications et suivre activement ce qui suit :

- Avoir un système comptable capable de produire des rapports financiers dans les 24 heures suivant la demande à faire au public puisque nous utilisons des dons publics.
- Produire des documents sources sur demande de toute réclamation faite directement ou indirectement dans leur rapport financier. Ceci est dans le but de vérifier les dossiers financiers.

FFGE বিশ্বকে বাঁচানোর জন্য পর্যাপ্ত সম্পদ সংগ্রহ করতে চাইছে না, তবে এটি তার সময় বিনিয়োগ করবে এবং অর্থনৈতিক, সম্প্রদায় এবং আধ্যাত্মিক উন্নয়নে "সহায়তা" করতে অর্থ দান করবে স্ব-টেকসই ব্যবস্থা প্রতিষ্ঠার আশায় যা অবশেষে একটি ছোট অংশ ফেরত দেবে প্রভু যীশু আরও নির্দেশনা দেওয়ার জন্য ফিরে না আসা পর্যন্ত মিশনটিকে স্থায়ী করুন। আমরা একটি বিশ্বাসী খ্রিস্টান অ্যাপোস্টোলিক মন্ত্রণালয় এবং একটি ব্যাংক বা তহবিল মন্ত্রণালয় নয়। LITWCHURCH এ আপনার একমাত্র আগ্রহ যদি অর্থায়ন হয়, অনুগ্রহ করে আবেদন করবেন না! আমাদের মানদণ্ড পূরণ হওয়ার পরেই আমরা তহবিল দেব। এই মানদণ্ডের মধ্যে, কিন্তু সীমাবদ্ধ নয়, স্বচ্ছতা, উপস্থিতি বাইবেলের কাঠামো এবং প্রশাসন (দশমাংশ ও অফারগুলির একমাত্র ঈশ্বর-অনুমোদিত গির্জার বিকাশ সহ), বিশ্বব্যাপী-অ্যাক্সেসযোগ্য অ্যাকাউন্টিং রেকর্ড এবং ব্যাঙ্ক অ্যাকাউন্ট অডিটিং, এবং প্রদর্শিত সম্মান, চরিত্র, এবং সততা - কয়েকটি নাম। FFGE সাধারণত তার পরিষেবাগুলি বিনামূল্যে প্রদান করবে যাতে মন্ত্রণালয়গুলিকে তাদের গীর্জাগুলিকে বাইবেলের সঠিক, আর্থিক এবং অর্থনৈতিক নীতিগুলির উপর ভিত্তি করে সংগঠিত করতে সাহায্য করে অর্থায়নের জন্য যোগ্য হতে সাহায্য করে।

কার জন্য FFGE?

FFGE হল বিশ্বব্যাপী মন্ত্রণালয়ের নেতাদের একটি কার্যকরী ফোরাম যে সকলেরই নিম্নলিখিত বৈশিষ্ট্য রয়েছে:

- নিজেদেরকে আর্থিকভাবে সমৃদ্ধ করার চেয়ে ঈশ্বরের বাক্য ছড়িয়ে দেওয়ার বিষয়ে বেশি চিন্তিতা

- একটি স্পষ্ট আর্থিক অ্যাকাউন্টিং সিস্টেম আছে যা প্রতিটি সম্পদ এবং দায় ট্র্যাক করে এবং যেটি 100% স্বচ্ছতার সাথে একজনের বর্তমান আর্থিক অবস্থা প্রদর্শন করে
- লিখিত LITWChurch অনার কোড যা ঈশ্বরের মানকে অনুসরণ করে তা গ্রহণ করে, সম্পাদন করে এবং জীবনযাপন করে
- পবিত্র বাইবেলে লেখা ঈশ্বরের পারিবারিক মূল্যবোধ এবং জীবনযাত্রার মানকে সমর্থন করে
- আমাদের তহবিল স্থায়ী করার জন্য FFGE-কে দশমাংশ ফেরত দিতে ইচ্ছুক
- দক্ষতা এবং আর্থিক দায়িত্বের প্রতিশ্রুতি
- অন্যান্য FFGE সদস্যদের তাদের পরিকল্পনা এবং উদ্দেশ্য উপলব্ধি করতে সহায়তা করার জন্য স্বেচ্ছাসেবক সময় দিতে ইচ্ছুক

কেন FFGE হয়

FFGE গঠিত হয়েছিল মন্ত্রণালয়ে সহায়তার জন্য বিশ্বব্যাপী অনুরোধগুলি পরিচালনা করার জন্য যা লাভ ইন দ্য ওয়ার্ড চার্চে আসে। দানকৃত তহবিলের দক্ষ এবং ভাল স্ট্রুচার্ড হওয়ার জন্য এবং অনুরোধগুলিকে অগ্রাধিকার দেওয়ার জন্য, LITWChurch একটি মালিকানা পয়েন্ট সিস্টেম তৈরি করেছে (পরে এই নথিতে বর্ণনা করা হবে) উদ্দেশ্যমূলকভাবে অগ্রাধিকারের আদেশের পরামর্শ দেওয়ার জন্য। বিষয়গত উদ্দেশ্য নিয়ে একতরফা সিদ্ধান্ত নেওয়ার পরিবর্তে, আমরা অন্যদের অন্তর্ভুক্ত করা ভাল বলে মনে করেছি যারা ইতিমধ্যেই ঈশ্বরের কাজ করতে ব্যস্ত। FFGE প্রতি মাসে অন্তত একবার সাইবারস্পেসে মিলিত হবে, Facebook লাইভে বিশ্বে সম্প্রচার করা হবে। মাসের একটি বৈশিষ্ট্যযুক্ত প্রকল্প থাকবে এবং আমরা যে কোনও আলোচনাকে উত্সাহিত করব যা উপস্থাপক FFGE সদস্যকে অন্যান্য FFGE সদস্যদের সম্মিলিত অভিজ্ঞতার উপর আঁকতে সহায়তা করে। উপস্থাপিত প্রকল্পের সমালোচনা ও আলোচনা করে, আমরা উপস্থাপক সদস্যকে FFGE-এর সাথে অর্থায়নের জন্য যোগ্যতা অর্জনে সহায়তা করার আশা করি।

লিটচার্চ মেম্বারশিপ প্রকার

LITWChurch এবং এর চার্চের নেটওয়ার্কে তিন ধরনের সদস্যপদ/অ্যাসোসিয়েশন রয়েছে:

1. কর্পোরেট চার্চ (টাইপ 1):

- গ. প্রতিটি চার্চের নেতৃত্বে একজন LITWচার্চ-নিয়ন্ত্রিত যাজক হতে হবে যিনি LITWChurch বোর্ড অফ ডিরেক্টরস দ্বারা দেশে নিযুক্ত একজন বিশপের কাছে রিপোর্ট করেন।
- d এই চার্চের যাজকগণ কর্পোরেট দ্বারা নিযুক্ত হন, দেশে বিশপ দ্বারা প্রশিক্ষিত, এবং সমস্ত LITW চার্চ-নিযুক্ত পাদরিদের মতো পরিচালনা পর্ষদের একমাত্র আনন্দে পরিবেশন করেন।
- e প্রতিটি LITWChurch-নিয়ন্ত্রিত যাজক দেশের মিশন কাউন্সিলে একটি ভোট দেন এবং LITWChurch-নির্ধারিত অঞ্চল বা মিশন বিশপকে সেই দেশের জন্য রিপোর্ট করেন।
- চ প্রতিটি বিশপ-ইন-কান্ট্রির কর্পোরেট আঞ্চলিক/মিশন কাউন্সিলে একটি ভোট রয়েছে যা কর্পোরেট বোর্ড অফ ডিরেক্টরসকে একটি হিসাবে রিপোর্ট করে ভোট।
- g এই গীর্জাগুলি মিশনের কাজের জন্য দানকৃত তহবিলের কমপক্ষে 60% নিয়ন্ত্রণ করবে যতক্ষণ না সেই শতাংশের আর কোনও প্রয়োজন না হয়।
- জ. LITWChurch পরিচালনা পর্ষদের আমাদের সনদ প্রত্যাহার করার এবং/অথবা যেকোন প্রকার 1 সদস্যকে একতরফাভাবে অপসারণ করার অধিকার রয়েছে, এবং যদি সদস্য এই ধরনের লঙ্ঘনের বিজ্ঞপ্তির 30 দিনের মধ্যে এই ধরনের লঙ্ঘনকে নিরাময় না করে উপ-আইন লঙ্ঘন করে তবে তার সম্পূর্ণ বিবেচনার ভিত্তিতে।
- i টাইপ 1 সদস্যরা পরিচালনা পর্ষদের দ্বারা যে কোনো নির্দিষ্ট সময়ে গঠিত সাংগঠনিক কাঠামোর মাধ্যমে প্রেসাইডিং বিশপের কর্তৃত্বের অধীনে পড়ে
- j আয়ের 20% পেস্টোরেট কেয়ারে যায়। আয়ের 10% শুধুমাত্র দেশে টাইপ 1 গীর্জা ব্যবহারের জন্য কান্ট্রি SEE-তে যায়।
- k. কর্পোরেটে কোন টাকা পাঠানোর কোন পরিকল্পনা নেই। কর্পোরেট এবং মহাদেশীয় পাদরি এবং কর্মীরা কর্পোরেট তহবিল দ্বারা অর্থায়ন করা হয়।

2. LITWChurch নেটওয়ার্ক:

- ক এই গীর্জাগুলি হল স্বায়ত্তশাসিত চার্চ তারা তাদের নিজস্ব আর্থিক ব্যবস্থাপনার জন্য এককভাবে দায়ী।
- খ. এই গীর্জাগুলি মিশনের কাজের জন্য দানকৃত তহবিলের 30% থেকে সম্মিলিতভাবে তহবিল পেতে পারে।
- গ. এই চার্চগুলি আমাদের চার্চগুলির নেটওয়ার্কের অংশ এবং তারা তাদের গীর্জার নামের সাথে যোগ করে "একটি LITWChurch নেটওয়ার্ক সত্তা"। এইভাবে, একটি মন্ত্রণালয় স্বাধীন থাকতে পারে কিন্তু ওয়ার্ড চার্চে লাভের বিশ্বব্যাপী নাম স্বীকৃতি থেকে উপকৃত হতে পারে।
- d এই গীর্জা হয় "পরামর্শদাতা" বা মেন্টরশিপ না থাকার জন্য নির্বাচন করতে পারে। একজন কর্পোরেট বিশপ নিযুক্ত না হওয়া পর্যন্ত এবং মেন্টরশিপ ছাড়াই চার্চের তুলনায় ফান্ড সহায়তার উদ্দেশ্যে উচ্চতর স্কের না করা পর্যন্ত মেন্টরশিপ সহ যারা অস্থায়ীভাবে LITWChurch-এর প্রতিনিধিত্ব করার যোগ্য।
- e যদি এমন ঘটনা ঘটে যে মেন্টরশিপ সদস্যের সাথে একজন টাইপ 2 দেশের অন্তর্ভুক্তী বিশপ হিসাবে কাজ করছেন, যখন LITWChurch বোর্ড অফ ডিরেক্টরস দেশে একজন মিশন বিশপ নিয়োগ করতে চায়, অন্তর্ভুক্তী টাইপ 2 বিশপের প্রথম প্রত্যাখ্যানের অধিকার থাকবে, কিন্তু তাদের অবশ্যই তাদের রূপান্তর করতে হবে। টাইপ 1 সদস্যপদ যেমন অধিকার ব্যায়াম করতে।
- চ তারা ওয়ার্ড চার্চ আইএনসিতে প্রেমের উপবিধি মেনে চলতে নির্বাচন করে, কিন্তু তাদের নিজস্ব সাংগঠনিক নথি দ্বারা পরিচালিত হয়। যদি LITWChurch এবং টাইপ 2 সদস্যের মধ্যে একটি

অমীমাংসিত পার্থক্য থাকে, তাহলে টাইপ 2 সদস্য সক্রিয় থাকা তহবিল নথি অনুসারে তাদের সদস্যপদ বাতিল করতে পারে।

g এই চার্চগুলি তাদের স্বচ্ছতা অঙ্গীকারের প্রয়োজনীয়তার অংশ হিসাবে কর্পোরেটের কাছে ত্রৈমাসিক আর্থিক বিবৃতি উপস্থাপন করে এবং ভুল-কর্ম বা আইন লঙ্ঘনের যে কোনও অভিযোগের মধ্যে থাকা যে কোনও অডিটিং ফাংশনে সহায়তা করার জন্য তথ্যের জন্য যে কোনও অনুরোধের সাথে সাথেই জমা দিতে হবে।

জ. টাইপ 2 চার্চগুলির কর্পোরেট বা টাইপ 1 চার্চগুলির জন্য কোনও আর্থিক দায়বদ্ধতা নেই, তাই সাধারণভাবে FFGE বা LITWChurch দ্বারা রেন্ডার করা যে কোনও পরিষেবার জন্য তাদের একটি যুক্তিসঙ্গত ফি দিতে হবে।

3. FFGE-অধিভুক্ত:

ক এগুলি সংজ্ঞা দ্বারা অ-খ্রিস্টান সংস্থা, মন্ত্রণালয় বা ব্যক্তি।

খ. এই সংস্থাগুলি এবং মন্ত্রণালয়গুলি LITWChurch-এর সাথে যুক্ত এবং আমাদের চার্চগুলির সাথে তাদের কোনো প্রত্যক্ষ বা পরোক্ষ সংযোগ নেই, তারা FFGE বেনিভোলেস ফান্ডিংয়ের জন্য যোগ্যতা অর্জন করতে চায়।

গ. এই সংস্থাগুলি মিশনের কাজের জন্য দানকৃত তহবিলের 10% নির্দেশ করে এবং মূলত LITWChurch-এর জন্য বিশ্বের জন্য লর্ডস কেয়ারে দশমাংশ দেওয়ার জায়গা প্রদান করে।

d এই মন্ত্রণালয়গুলি খ্রিস্টান নয় এবং অনুমোদনের দ্বারা অনুমোদিত, যতক্ষণ না তারা পবিত্র বাইবেলে বর্ণিত এবং LITWChurch নেতৃত্ব দ্বারা ব্যাখ্যা করা যিশু খ্রিস্টের মানদণ্ডের সাথে সামঞ্জস্যপূর্ণভাবে মানবতাকে ভালবাসা এবং যত্ন নেওয়ার কাজে জড়িত থাকে।

e এই সিদ্ধান্তটি যে সত্যটির উপর নির্ভর করে তা হল খ্রিস্টানদের মঙ্গল, সদৃশতা, সম্মান, সততা এবং স্ট্রুয়ার্ডশিপের উপর একচেটিয়া অধিকার নেই।

চ যেকোন অ-খ্রিস্টান সদস্যকে অবশ্যই FFGE প্রকার 3 সদস্যতার জন্য LITWChurch প্রিসাইডিং বিশপ এবং/অথবা পরিচালনা পর্ষদের দ্বারা করা যেকোনো অনুরোধ জমা দিতে হবে।

g টাইপ 3 FFGE নন-খ্রিস্টান সদস্যপদ প্রিসাইডিং বিশপের দ্বারা অনুমোদিত এবং কর্পোরেট বোর্ড অফ ডিরেক্টরস দ্বারা অনুমোদিত হতে হবে

অর্থায়নের জন্য প্রয়োজনীয়তা:

FFGE থেকে তহবিল প্রাপ্ত যেকোন মন্ত্রণালয়কে অবশ্যই সম্মত হতে হবে, এর যোগ্যতা পূরণ করতে হবে এবং সক্রিয়ভাবে নিম্নলিখিতগুলি অনুসরণ করতে হবে:

- সমস্ত মুদ্রা কীভাবে ব্যয় করা হয় তাতে 100% স্বচ্ছ হন।
- একটি অনার কোড অঙ্গীকার স্বাক্ষর করুন এবং এটি দ্বারা আবদ্ধ হতে সম্মত হন।
- কিছু পারস্পরিক সম্মত সময়ে FFGE-এর ফান্ডিং পুলে মোট প্রাপ্তির 10% ফেরত দিতে সম্মত হন।

- কমপক্ষে ছয় মাসের জন্য যেকোনো ধরনের FFGE-এর সদস্য হন।
- FFGE-এর একজন সক্রিয় সদস্য হিসেবে অংশগ্রহণ করুন, অন্য FFGE সদস্যদের কথা শোনার জন্য এবং তাদের লক্ষ্য অর্জনে সহায়তা করার জন্য কিছুটা সময় দান করুন। এই মেট্রিকের জন্য যত বেশি ধারাবাহিক অংশগ্রহণ, তত বেশি পয়েন্ট।
- অযৌক্তিকতা, অব্যবস্থাপনা, বা সম্মান লঙ্ঘনের যেকোনো অভিযোগের উত্তর দিতে ইচ্ছুক হন।

অর্থায়নের জন্য স্কোরিং সিস্টেম

ফান্ডিং অনুরোধের মূল্যায়নের জন্য সঠিক স্কোরিং রুব্রিক সময়ের সাথে পরিবর্তিত হবে। এই স্কোরিং স্কিম একটি "রুব্রিক" বলা হয়। রুব্রিকের প্রতিটি ভেরিয়েবল দুটি বিভাগের মধ্যে একটি হিসাবে শ্রেণীবদ্ধ করা হয়েছে - FFGE-শ্রেণী এবং প্রকল্প-শ্রেণী। প্রতিটি বিভাগে ক্যাটাগরির প্রকারের (আন্তঃ-বিভাগ শতাংশ) মধ্যে একটি ওজন থাকে যা একসাথে যোগ করলে মোট 100% হয়। প্রতিটি বিভাগের মধ্যে (ইন্ট্রা-ক্যাট শতাংশ), প্রতিটি ভেরিয়েবলের একটি ওজন রয়েছে যা প্রতিটি বিভাগের মধ্যে 100% "মোট"। প্রতিটি ভেরিয়েবলের সর্বোচ্চ স্কোর রয়েছে 100 পয়েন্ট। প্রতিটি পরিবর্তনশীল অবস্থা তার মানের উপর ভিত্তি করে একটি পয়েন্ট পাবে এবং মোট বা সমষ্টিগত মান প্রতিটি প্রকল্পকে অগ্রাধিকার দেবে - 0 থেকে 100 পর্যন্ত একটি স্কোর। উচ্চতর মান সর্বোচ্চ অগ্রাধিকার। বর্তমানে তহবিলকে অগ্রাধিকার দেওয়ার সময় নিম্নলিখিত ভেরিয়েবলগুলি স্কোর করা হয়:

NZIRA YEDU

Nekuvaka zvivakwa zvechechi zvinova nzvimbo dzenharaunda dzekudzidza nekuchengeta, chechi inova musimbotti wenharaunda yega yega yemhuri yega yega iri kutsvaga nzira irinani yekusimudzira hupenyu. Chinangwa ndechekuita kuti nharaunda yega yega igone kuzvimirira kuburikidza nekuunza misimbotti yekutonga kwemari, kushambadzira, hutsanana hwemunhu, kujekeswa kwemweya uye kutonga kwebhizinesi. Chechi ichave musimbotti wekudzidziswa kwehunyanzvi hwepasi rose semutauro, tekinoroji, uye dzidzo yehurongwa hwepasirese, hwakadai sehupfumi hwenyika, mapurojekiti erubatsiro emarudzi akawanda, kurongeka kwehutano hweveruzhinji, kutaura misoro mishoma.

ZVATUSINA KUFARIRA

FFGE haisi kutarisa kuti iunganidze zviwanikwa zvakakwana kuti iponese nyika, asi ichaisa nguva yayo uye nekupa mari "kubatsira" hupfumi, nharaunda, uye budiro yemweya mune tariro yekumisa masisitimu ekuzvitsigira ayo anozobhadhara chikamu chidiki fambisa basa racho kusvikira Ishe Jesu vadzoka kuzopa mimwe mirairo. Isu tiri shumiro yekutenda kwechiKristu yeApostora uye kwete shumiro yebhangi kana MARI. Kana kufarira kwako chete muLITWCHURCH kuri mari, ndokumbira usaite! Isu tinongobhadhara mushure mekunge maitiro edu azadziswa. Pakati pezvipimo izvi, asi zvisingagumiri pazviri, jekerere, kuvapo kwebhaibheri chimiro nekutonga (kusanganisira iyo yega kereke inotenderwa naMwari kuvandudzwa kwechegumi nemipiro), rekodhi rekaunzi rinowanikwa pasi rose uye kuongororwa kwekaundi yekubhangi, uye yerukudzo, chimiro, uye kuvimbika - kutaura zvisoma. FFGE inowanzopa masevhisi ayo MAHARA HERE kubatsira hushumiri kuti vakwanise kuwana mari nekuvabatsira kuronga makereke avo zvichienderana negwara rakanaka rebhaibheri, remari, uye nehupfumi.

FFGE NDEYAANI?

FFGE iforamu inoshanda yevatungamiriri vehushumiri hwepasirese avo vese vane zvinotevera hunhu:

- Kunyanya kunetseka nezvekuaparadzira SHOKO raMwari pane kuzvipfumisa ivo pachavo nemari
- Kutsvaga imwe mari yekutsigira chironzwa chekubatsira vanhu, hupfumi, nharaunda, uye/kana zvemweya muhukuru.
- Iva neyakajeka yezvemari accounting system inoteedzera midziyo yese nemhosva uye inoratidza mamiriro emari aripo ne100% pachena.
- Anotora, oita, uye anorarama maererano nerakanyorwa LITWChurch Honor Code rinotevera mwero waMwari.
- Inotsigira tsika dzemhuri yaMwari uye mararamiro akanyorwa muBhaibheri Dzvene
- Kuda kubhadhara chegumi kuFFGE kuti Fund yedu irambe iripo
- Kuzvipira kushanda zvakana uye basa remari
- Kuda kuzvipira kubatsira dzimwe nhengo dzeFFGE kuona hurongwa nezvinangwa zvavo

NEI FFGE

FFGE yakaumbwa kuti itonge zvikumbiro zvepasi rose zverubatsiro muhushumiri zvinouya muRudo Mulzwi Chechi. Kutitave vatariri vane hunyanzvi uye vakanaka vemari dzakapihwa uye kuitira kuti zvikumbiro zvikoshese mberi, LITWChurch yakagadzira a proprietary point system (ichatsanangurwa gare gare mugwaro rino) kuti iratidze kurongeka kwekutanga. Pane kuti tiite zvisarudzo tiine chinangwa chokuzvisarudzira, takaona zviri nani kubatanidza vamwe vakatobatikana kuita basa raMwari. FFGE ichasangana mucyberpace kamwechete pamwedzi, ichitepfenyurwa paFacebook Live kupasirese. Pachava nechironzwa chemwedzi uye tichakurudzira nhaurirano ipi neipi inobatsira nhengo yeFFGE iri kuratidza kukwevera pane zvakaitika kune dzimwe nhengo dzeFFGE. Nekutsoropodza nekukurukura purojekiti yakaratidzwa, tinotarisa kubatsira nhengo iripo kuti ikwanise kuwana mari neFFGE.

Mukati mechikamu chega chega (Intra-Cat Percentage), imwe neimwe shanduko ine huremu

hunokwana 100% "mukati mechikamu chimwe nechimwe. Imwe neimwe shanduko ine zvibodzwa zvakananyanya zve100 zvibodzwa. Pomanga nyumba za mipingo zomwe ndi malo ophunzirira ndi chisamaliro cha anthu, mpingo umakhala phata la dera lililonse la banja lililonse lofunafuna njira yabwino yochirikizira moyo. Cholinga ndikupangitsa kuti dera lililonse likhale lodzidalira poyambitsa mfundo za kayendetsedwe ka ndalama, malonda, ukhondo waumwini, kumveka bwino kwauzimu ndi kayendetsedwe ka bizinesi. Mpingo udzakhala likulu la maphunziro a luso lapadziko lonse lapansi monga chinenero, luso lamakono, ndi maphunziro a machitidwe apadziko lonse, monga chuma cha padziko lonse, ntchito zothandizira anthu zamitundu yosiyanasiyana, mgwirizano wa zaumoyo wa anthu, kutchula mitu yochepa.

FFGE idapangidwa kuti iziyang'anira zopempha zapadziko lonse zothandizira muutumiki zomwe zimabwera mu Love In The WORD Church. Pofuna kukhala oyang'anira bwino ndalama zomwe zaperekedwa komanso kuti zikhazikitse zopempha patsogolo, LITWChurch yakhazikitsa njira yoyendetsera umwini (yomwe iti ifotokozedwe m'chikalatachi) kuti ipereke malingaliro ofunikira. M'malo mopanga zosankha ndi zolinga zongoganizira chabe, tinaona kuti ndi bwino kuphatikizirapo ena amene atanganidwa kale ndi ntchito ya Mulungu. FFGE imakumana pa intaneti kamodzi pamwezi, kuwulutsidwa pa Facebook Live padziko lonse lapansi. Padzakhala pulojekiti ya mwezi uno ndipo tidzalimbikitsa zokambirana zilizonse zomwe zimathandiza membala wa FFGE kuti agwiritse ntchito zomwe mamembala ena a FFGE akumana nazo. Podzudzula ndikukambirana za polojekiti yomwe yaperekedwa, tikuyembekeza kuthandiza membala yemwe akupezeka kuti ayenerere kulandira ndalama ndi FFGE.
